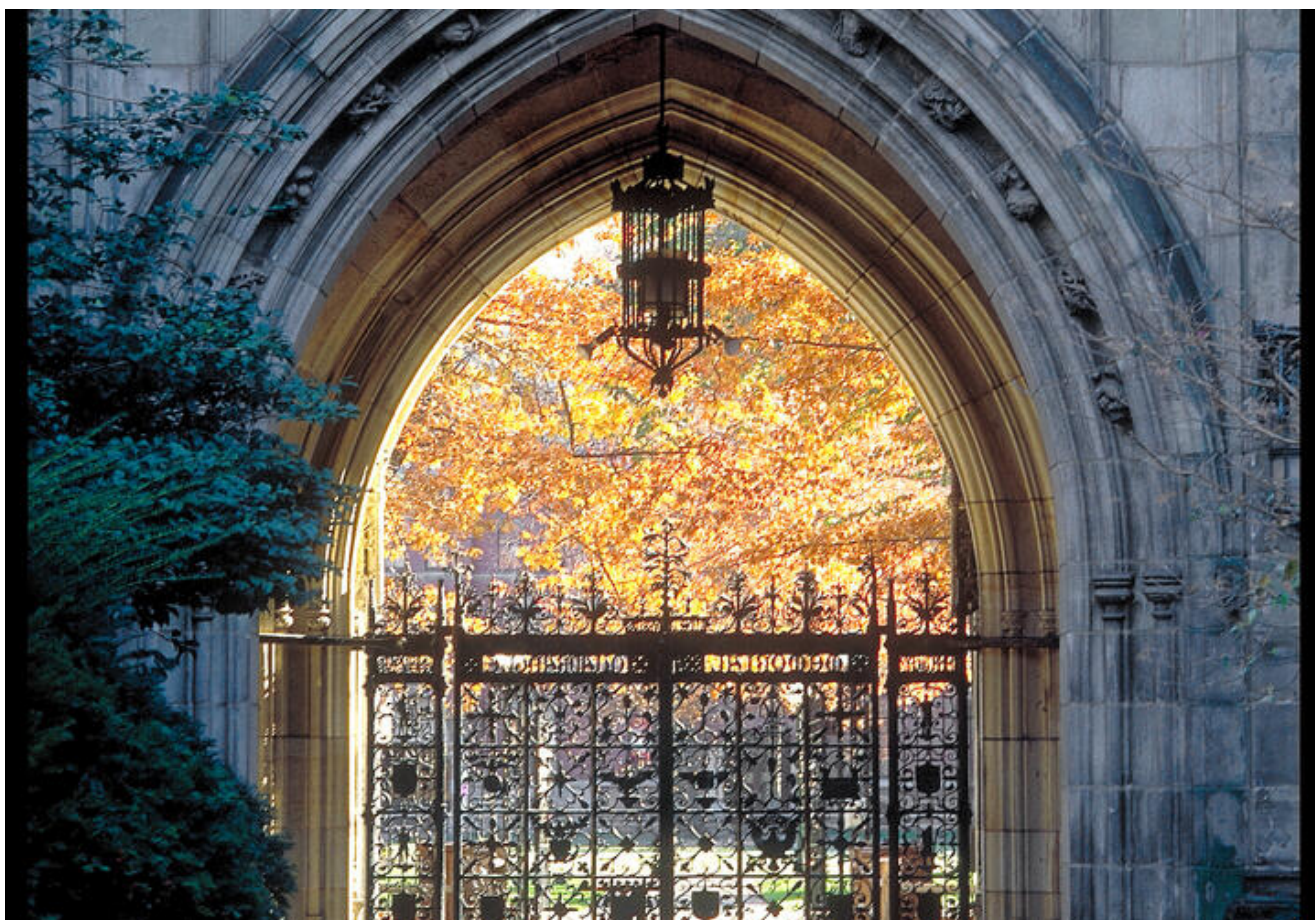


## Legal Considerations
