
Sprintax Returns Tax Preparation Software

OISS covers the cost of your federal income tax return if you file using Sprintax Returns. You **must access Sprintax Returns via the links on our website** (see below) to use this discount and for it to be automatically applied at the checkout. Yale offers a limited number of Sprintax Returns codes for each tax year. Please file as early as possible. Although we usually have enough codes for all our students and scholars, we cannot guarantee a Sprintax Returns discount code, especially after the April tax deadline.

You can use Sprintax Returns to prepare your state taxes (if applicable) for an additional fee. Please see step 6 below for more information.

Important Note:

Sprintax Returns is only for **nonresident taxpayers with U.S. source income**

If you have a valid NetID, click the first link, and the discount code will be automatically applied at the checkout. If

[Step 1: Confirm Your Tax Residency Status](#)

After logging in to Sprintax Returns, you will be asked a series of questions about your time in the U.S. in recent years. Sprintax Returns will then determine your tax status. If it determines that you are a “nonresident” (NRA) for federal tax purposes, you can continue to use the software and prepare your nonresident tax return.

However, if Sprintax Returns determines that you are a resident for federal tax purposes, you will not be able to use the software. In that case, [please see our page for resident taxpayers](#) [13].

[Step 2: Getting to Know You](#)

Answer the personal- and immigration-related questions in Sprintax.

[Step 3: Let's Talk Money](#)

Add the income documents you've received and answer the tax-related questions.

[Step 4: Offset Your Expenses](#)

Answer questions about certain payments you've made in the past year, as they may reduce the amount of income that you owe taxes on.

[Step 5: About Your College](#)

Add details about Yale and your program director from your DS-2019 or I-20.

[Step 6: State Taxes](#)

Determine if you need to fill out a state income tax return by listing any U.S. states you've lived in, as well as time you've spent outside the U.S. Sprintax Returns will inform you if you need to complete a state tax return. If so, you will have the option to use Sprintax Returns for an additional fee. However, it is your choice to use them or to do the state tax return on your own. [Step 7: Review and Submit Your Return](#)

Summary

Review all the information you've entered to confirm that it is accurate. Afterwards, Sprintax Returns will generate all your tax return documents:

- a completed Form 8843 for you (and each of your dependents)
- a federal tax return, Form 1040NR

Federal Tax

Many filers may be able to e-file their federal tax documents through Sprintax Returns. In order to do so, you must verify your identity by providing information from last years' tax return (or enter 0) and creating or entering a PIN number to use as an electronic signature.

State Tax

E-filing does not apply to state income tax returns. If you have a state filing requirement, you must print and mail this to the relevant tax authorities of that state. [Learn more about this here](#) [14].

If you do not want to e-file or you are not eligible, you will be required to download, print and sign your federal tax return and mail it to the IRS. If you have a state filing requirement, you must also mail this to the relevant tax authorities of that state. [Learn more about this here](#) [14].

Post-Filing Support

Sprintax Returns will offer to provide post-filing support for an additional fee. This is not required, and you can bypass it by clicking the 'I would like to handle all post-filing communication with the IRS myself at no additional cost' box, then clicking the Next button. Please note that OISS does not provide this post-filing support for individuals, so you must determine if you want to skip this post-filing support for yourself.

Sprintax Forms

Sprintax will offer to help you with pre-employment paperwork for an additional fee. This fee is not required, and you can bypass it by clicking the 'Proceed without Sprintax Forms' link (under the red button), then clicking the Next button. The [Yale International Tax Office](#) [15] should be able to assist you with preparing your pre-employment paperwork correctly, however you must determine for yourself if you want to obtain Sprintax's support.

[Step 8: Finalizing](#)

If you have used OISS's link to access Sprintax Returns, you should now be presented with your total amount owed, with the Federal Return fee deducted automatically. If this fee has not been deducted automatically, please contact alina.nevins@yale.edu [16] before completing this step so we can address this for you.
